

### **Bicycle rental terms and policies**

1. For reasons of security and compliance with the terms of the rental agreement, the lessee owes and agrees to hand over his/her identity card, passport, or driving license to the company for the duration of the rental period. The document will be returned to him at the end of the rental and the return of the bicycle at the same condition it was received. For the duration of the rental of the bicycle, the company will deliver to the lessee a copy of the document. Alternatively, the company keeps a copy of the lessee's identity card or passport or driving license and a EUR 300.00 guarantee for each bicycle, which will be refunded by deducting the cost of the rental and any costs incurred in the event of damage or loss of part of the bicycle. If the cost exceeds the amount of the guarantee, the lessee is obliged to cover it.
2. Due to regulations, no bikes will be offered to persons under the age of 18 not accompanied by a parent or a guardian.
3. The lessee must be aware of the use of bicycles and there is no medical instruction/indication for non-use.
4. The lessee declares that before each rental, inspects the bicycle and the functionality of it, and concludes that it is of irrevocable acceptance and is picked up in excellent manufacturing condition and functionality. The lessee, under no circumstances proceeds with a rental, if there is a fault on the leased bike. Picking up a bike for rental, constitutes the aforementioned declaration – acceptance of all the terms and policies.
5. The use of protective helmet during every rental/lease was instructed during the registration and a protective helmet was delivered to the lessee.
6. The lessee is obliged to use the bicycle properly, conforming to the public safety rules and the laws governing safe driving.
7. It is forbidden for the lessee to borrow, rent or lease the bicycle to other persons.
8. The lessee declares that he/she will not use the bicycle under the influence of alcohol or other substances.
9. The company will under no circumstances be liable for any accidents and/or damage to the driver or third parties caused by the improper behavior or driving of the driver, as well as criminal mischief during the rental. Solely responsible/liable for all above mentioned is the user/driver/lessee.
10. In case of damage to the bicycle during the rental period, the lessee is obliged to inform the company and return the bicycle to the company.
11. In the event of total destruction, loss or theft of the bicycle during the rental or non-return of the bicycle, the lessee must compensate the company for the amount of EUR 1.000 euros for each bicycle. In the event of damage to or loss of part of the bicycle or its accessories, the lessee must compensate the company for the replacement of the spare part/accessory.
12. The lessee will be held responsible for all damages of the bike and the accessories during the rental period, either caused by him/her or not.
13. Minimum rental duration is 1 hour. In case of returning prior to the rental period agreed, the company will not be liable for refunds. If the lessee returns the bike later than the agreed time and day, the additional charge is EUR 10.00 per 1 hour in addition to the original agreed return time and day.
14. Upon receipt of the vehicle, the lease agreement containing the above terms and conditions is signed by the lessee.
15. For any dispute arising of the rental, the courts of Athens have exclusive jurisdiction. The Greek law shall be applied to the dispute, and in any case that it is not mentioned here, the relevant provisions of the Greek Civil Code are in force.
